Registration Fee: A \$50 non-refundable registration fee is required to hold your space for programs offered by Polarity Healing Arts of California.

Payment Plans: Payment in full for any class may be made at the time of enrollment. However, installment arrangements can be made for any of the courses through the business. Visa, Master Card, Discover and American Express are accepted.

Buyers Right to Cancel: Students may withdraw or cancel at any time. Cancellation must be given in writing either in person or by mail.
